#### Introduction

- 1. By correspondence dated June 21, 2024, the Hon. Deputy Esteban Lazo Hernandez, President of the National Assembly of the People's Power of Cuba ("National Assembly") issued an invitation to the Hon. Bridgid Mary Annisette-George, MP, Speaker of the House of Representatives to undertake an official visit Cuba. (A copy of the Invitation Letter is attached at Appendix 2)
- 2. The Parliamentary delegation comprised the following persons:
  - Hon. Bridgid Mary Annisette-George, MP Speaker of the House and Leader of the Delegation;
  - Hon. Lisa Morris-Julian, MP Minister in the Ministry of Education;
  - Mr. Rudranath Indarsingh, MP Member for Couva South;
  - Sen. Helon Francis Independent Senator;
  - Mr. Julien Ogilvie Deputy Clerk and Secretary to the Delegation.

#### Aim and objectives of the visit

- 3. The official visit was intended to demonstrate the commitment of the legislatures to the deepening of parliamentary relations. It also served as an opportunity for both countries to explore additional areas of Parliamentary cooperation, including the creation of a *Parliamentary Friendship Group* which is intended to strengthen cooperation between the members of the National Assembly of Cuba and the Parliament of the Republic of Trinidad and Tobago in mutual areas of interest.
- 4. In this regard, the visit was anchored on the following areas of mutual interest:
  - a. Legislative and Procedural Guidance;
  - b. Women Empowerment and Gender Equality;
  - c. Education;
  - d. Culture and Sport;
  - e. Health Sector Scrutiny;
  - f. Disaster Preparedness and Resilience;
  - g. Heritage Management;
  - h. Sustainability.

- 5. A programme of activities undertaken by the delegation during the official visit is at **Appendix 1.**
- 6. This report is being presented in accordance with Standing Order 22(6) and 21(6) of the House of Representatives and Senate, respectively.

#### **Summary of Activities**

#### Official Welcome

The delegation arrived in Cuba at the "José Martí" International Airport on Sunday September 01 2024 (1pm). The delegation was received by Hon. Ana María Mari Machado, Vice President of the National Assembly and Ms. Cindy Maharaj. Charge d' Affaires a.i. and Head of Mission of the Embassy of the Republic of Trinidad and Tobago in Havana. They were accompanied by other deputies of the National Assembly and staff of the Embassy.

#### Day 2: MONDAY- SEPTEMBER 2<sup>ND</sup>, 2024

The official visit of the Honourable Speaker of the House of Representatives commenced with a Floral Wreath Laying Ceremony which was hosted by the Embassy of Trinidad and Tobago and the Ministry of Foreign Affairs of Cuba (MINREX) in commemoration of the 62<sup>nd</sup> Anniversary of Independence of the Republic of Trinidad

and Tobago. The ceremony was held at the Caribbean (CARICOM) Heroes Park in Havana.

The Honourable Speaker and the members of the delegation were received by Hon. Ana María Mari Machado, Vice President and members of the National Assembly. The Independence Day Programme comprised a guard of honour and salute by the Cuban military ceremonial officers and the playing of the National Anthems of Trinidad and Tobago and Cuba.

Also in attendance were deputies of the National Assembly, Cuban Officials and Government Representatives of MINREX, Ambassadors, Heads of Mission, diplomatic representatives and Members of Staff of the Embassy of the Republic of Trinidad and Tobago in Havana.

#### Visit to Trinidad and Tobago Embassy in Havana

Following the wreath laying ceremony, the delegation paid a courtesy visit to the Embassy of the Republic of Trinidad in Tobago, Havana. The delegation met and engaged with staff members and obtained insights into the work the Embassy has undertaken on behalf of the people of Trinidad and Tobago.

Madam Speaker and the other members of the delegation were invited to sign the visitor's book and a tour of the Embassy was conducted.

#### Visit to the Ministry of Science, Technology and Environment (CITMA)

The Honourable Speaker and delegation met with Ms. Odalys Goicochea Cardoso, Director General of the Ministry of Science and Technology and the Environment (CITMA) and other officials of that Ministry.

The Director General explained that although the institute experienced financial constraints, it was able to strengthen its national initiatives to adhere to the Paris Agreement to address climate change. He stated that Cuba had been experiencing higher storm frequencies and increased temperatures as a result of climate change. In this regard, the Director General explained that Cuba undertook measures to reduce greenhouse gas emissions, to develop national resources /renewable energy and to disaster risk management policies support through "the State Plan to Address Climate Change in the Republic of Cuba" or "Tarea Vida1" which was adopted in April 2017<sup>2</sup>.

A presentation entitled "Cuba: a future resilient to climate change" was made by the Director General. The presentation highlighted the specific strategies of the Government and emphasized that implementation of the "Tarea Vida" promoted broad citizen participation, which focus on equity and social inclusion.

The Honourable Speaker thanked the Director General for the opportunity to meet during this important visit. She also expressed gratitude for the information shared regarding climate change and the environment. The Speaker acknowledged that climate change issues such as the rise in sea levels and hurricane intensity were also affecting the economies of the region and exacerbated food security challenges. She pointed out that it was in our common interest to share experiences and best practices with respect to climate change, disaster preparedness and resilience, noting that Small Island Developing States (SIDS) were at a disadvantage due to its vulnerabilities.

#### Visit to the Chamber of Commerce of the Republic of Cuba

The delegation then met with the President of the Chamber of Commerce of Cuba. At the meeting, Madam Speaker reiterated the long-standing trade linkages between Trinidad and Tobago and Cuba, particularly in manufacturing. Discussions also underscored the significant role that Small and Micro Enterprises can play in strengthening trade activities between both countries as well as the importance of air transportation between both islands as is currently facilitated by Caribbean Airlines and

COPA airlines. The Chamber President also referred to Cuba's annual international trade fair and extended an invitation for our manufacturers to attend and participate.

The delegation took special note of Cuba's "Green economy" initiatives which included the manufacturing of artificial wood created from waste material. This synthetic wood is used in coastal erosion projects.

#### **Visit to the Ministry of Foreign Trade and Foreign Investment**

The official agenda for the day concluded with a visit to the Ministry of Foreign Trade and Foreign Investment. In the absence of the substantial Minister, the delegation held discussions with Hon. Deborah Rivas Saavedra, Vice-Minister. During the meeting, Madam Speaker acknowledged the important work that is being done between both countries to expand and deepen our trade relations. The delegation was informed that twenty (20) manufacturers from Trinidad and Tobago participated in Cuba's Trade Fair in 2023. In the context of CARICOM, the Vice-Minister highlighted that there is potential to boost cooperation in the area of maritime services.

#### Day 3: TUESDAY- SEPTEMBER 3rd, 2024

#### Visit to the Monument of the National Hero "José Martí"

The day commenced with a wreath laying ceremony at Revolution Square, the Monument of Jose Marti<sup>3</sup>. Mr. Marti is credited for his significant contribution to Cuba's battle for independence from Spain and was also an inspiration for Fidel Castro's revolution to free Cuba from another era of dominance. The delegation received a guided tour of the facility. Thereafter Madam Speaker signed the visitors' book.

## Official Welcome at the National Assembly of People's Power of the Republic of Cuba, National Capitolio.

Upon our arrival at the Capitolio, the traditional home of the legislature, the delegation was received by the Honourable Deputy Esteban Lazo Hernandez, President of the National Assembly. A Guard of Honour was assembled, and the national anthem of both countries were played. President Lazo Hernandez then led a brief tour of the Capitolio which included a visit to the historic Chamber of Deputies, which is no longer used.

The National Assembly of People's Power is the supreme organ of State power. The Assembly is unicameral and is the only body with constituent and legislative power in Cuba. It is made up of deputies elected by the free, equal, direct and secret vote of the electors, according to the procedure determined by law. According to Article 109 of the Constitution of the Republic, within the powers of the National Assembly of People's Power it is necessary to elect the President and the Vice President of the Republic. The Assembly is currently composed of 470 deputies who serve 5-year terms. Women constitute 55% of the Assembly's membership or 262 members and there are 208 men<sup>4</sup>.

Cuba is a one-party state, and all candidates are nominated by government bodies controlled by the Communist Party of Cuba (PCC). No other political parties are officially recognized or permitted to operate in Cuba.

Discussions commenced with official statements presented by President Lazo Hernandez and Speaker Annisette-George. In her remarks, Speaker Annisette- George highlighted the main areas in which she believed both Parliaments can achieve a greater level of cooperation. These included:

- a. Legislative and Procedural Guidance;
- b. Women Empowerment and Gender Equality;
- c. Education;
- d. Culture and Sport;
- e. Health Sector Scrutiny;
- f. Disaster Preparedness and Resilience;
- g. Heritage Management;
- h. Sustainability.

Speaker Annisette-George formally presented a letter to the President of the National Assembly proposing the formation of a *Parliamentary Friendship Group* between the Parliament of the Republic of Trinidad and Tobago and the National Assembly of the People's Power of the Republic of Cuba. Madam Speaker commended President Lazo Hernandez on their success in maintaining the structural integrity and physical appearance of the Capitolio and the other national heritage buildings in Havana. In this regard, she was particularly interested in the role played by the Office of the Chief Architect which oversees these efforts. For example, the delegation was informed that the light fixtures in the Capitolio were over 100 years old but were still functional. Madam Speaker reflected on our own experience in Trinidad and Tobago in maintaining our heritage infrastructure and referenced the Red House building and the contributions made by Cuban artisans during its restoration which was completed in 2020.

Following formal proceedings at the Capitolio, the delegation was invited to lunch courtesy President Lazo Hernández at Protocol House No. 18 in Laguito, over which informal discussions continued.

#### Presentation of the National Folklore Ensemble of Cuba.

The delegation was then transferred to the Auditorium of the National Library to observe a presentation by the National Folklore Ensemble of Cuba. Founded in 1962, the mission of the group is to undertake research, create and retain the indigenous folk and religious dances of the Cuban people. The presentation was well received by the delegation and was an excellent depiction of the rich and diverse cultural heritage of Cuba and the benefit of targeted policies to preserve Cuban Culture and folklore.

#### Day 4: WEDNESDAY- SEPTEMBER 4th, 2024

#### Special school "Solidarity with Panama"

"Every Life is worthy and has a productive potential for the benefit of the whole society" this is the ethos of this special needs education centre which was inaugurated by President Fidel Castro on December 31, 1989. The school was designed for children from preschool to ninth grade and caters primarily for children with physical/motor disabilities. As at 2022, there were approximately 34,000 children with disabilities enrolled in special education schools<sup>5</sup>. Additionally, there are 342 special schools supported by an estimated 14,000 teachers. There are at least two other similar schools throughout Cuba, these are locate in Santiago de Cuba and Villa Clara<sup>6</sup>.

Hon. Lisa Morris-Julian, Minister in the Ministry of Education, made a presentation to the Principal of the school. In her brief remarks, she commended the administrators of the school for their love for and dedication to special needs education in Cuba. In making a comparison between the services and amenities available at the centre and those available in Trinidad and Tobago, the Honourable Minister suggested that both countries could benefit from exchanging ideas regarding the delivery of special needs education.

The delegation conducted a tour of the school and was accompanied by President Lazo Hernandez and other officials of the National Assembly.

#### **Visit to the Finlay Vaccine Institute**

The visit to the special needs school was followed by a visit to the Finlay Vaccine Institute. The Finlay Institute was created in 1991 with the aim of further expanding the achievement of a group of Cuban scientists who investigated, produced and presented a vaccine against Neisseria meningitidis<sup>7</sup>. The Institute is a scientific organization created in honour of Dr. Carlos Juan Finlay, a renowned Cuban epidemiologist, who discovered that yellow fever is transmitted through an intermediate biological agent, capable of person-to-person transmission. This finding was essential to fight the disease, but more importantly, it served as the basis for research into what is known today as "vector-borne diseases."

Dr. C. Vicente Vérez Bencomo, General Director of the Center deliver an in depth and insightful presentation on the work of the Centre. Some of the notable aspects of the Centre's activities includes:

- a. developing vaccines, supported in the areas of Research and Development, Production, Clinical Evaluation and Marketing of products and technologies;
- b. pioneering research on mosquito borne illnesses;
- c. producing three Cuban-based vaccines against the Covid-19 virus that have a high level of effectiveness;
- d. the first large-scale production and clinical trials of a synthetic polysaccharide vaccine, against the Haemophilus influenzae type B bacterium.

#### Visit to the Fidel Castro Center

The delegation was honoured to be hosted by the Fidel Castro Center. The Centro is a museum, library and research institution, and welcomes people interested in conducting research<sup>8</sup> about the life of Fidel Castro. The facility is meticulously designed and outfitted and featured several chronological depictions of the life of Cuba's revered revolutionary and Commander in Chief, Fidel Castro. These depictions were expertly presented using several types of multi and digital media technologies that allow visitors to directly interface with the items on display.

#### Meeting with President of the People's Power of Cuba

The day's activities concluded with a courtesy call on His Excellency, Miguel Diaz Canel, First Secretary of the Central Committee of the Communist Party of Cuba and President of the Republic, which was held at the Palace of the Revolution located in Havana, Cuba.

Speaker Annisette-George expressed gratitude on behalf of the delegation, for the hospitality and courtesies extended by the Government and People of Cuba. She reiterated that the visit by this Parliamentary Delegation from the Republic of Trinidad and Tobago was a tangible demonstration of a strong interest in exploring opportunities for deepening cooperation between the legislative arm of our countries. Madam Speaker updated President Diaz Canel on the details and intended outcomes of the

meeting held with the President of the National Assembly at the Capitolio on Tuesday 4<sup>th</sup> September.

#### Day 5: THURSDAY- SEPTEMBER 5th, 2024

The fifth day commenced with a visit to the Mariel Special Development Zone. The Mariel Special Development Zone was officially opened in November 2013 and is a project aimed at attracting foreign direct investment critical for the local economy, while offering foreign investors opportunities to develop projects in several industrial fields. Mariel currently houses approximately 60 enterprises engaged in various commercial activities including manufacturing, food production, construction supplies, renewables energy, tobacco and even tourism, among others.



During the discussions, members of the delegation noted the similarities between Mariel and the Industrial Parks and Estates in Trinidad and Tobago. Of note was the extensive use of solar energy at Mariel which capacity exceeded the demand of the occupants of the zone. As such, this surplus is fed into the national electricity grid.

#### Tour of Viñales Valley and other environmentally sustainable spaces

The delegation then proceeded to the Vinales Valley. Viñales is located in the western region of *Sierra del Rosario*. Designated as a UNESCO World Heritage site in 1999, the valley is recognized for its pristine landscape encircled by mountains and dotted with spectacular dome-like limestone outcrops (*mogotes*) that rise as high as 300 metres. Traditional methods of agriculture have survived largely unchanged on this plain for several centuries, particularly for growing tobacco.

The delegation was honoured to be hosted by the Governor of the province of Pinar del Rio, Deputy Eumelin Gonzales-Sanchez and the Assembly representative for Vinales, Deputy Julio Emilio Morejón Pérez. Mr. Perez had represented Cuba at the Regional Seminar for Parliaments of the Caribbean on Climate Change and Sustainable Development held in Port of Spain from May 27-29, 2024<sup>9</sup>.

The delegation took particular interest in the environmentally sustainable activities and enterprises within the Vinales region. These included a locally operated restaurant with a menu that featured agricultural produce grown within the area. This was indicative of a forward linkage between the local agriculture industry and the tourism and hospitality sectors.

#### Visit to Las Terrazas<sup>10</sup>

The delegation also visited Las Terrazas, a small rural eco-community located in the eastern part of Sierra del Rosario, the mountain range that covers the westernmost tip of the island. Las Terrazas, represents a notable example of sustainable development in its most authentic form. The community evolved over many generations whereby its inhabitants adopted the practice of co-existing with the natural environment.

The evolution of the community is credited in part to the first Agrarian Reform which was implemented in 1959. Through this reform initiative one hundred peasants living in Sierra del Rosario received two caballerías (approximately 27 hectares) of land in this territory and they used it to grow minor crops.

In 1968, the need to implement economic and social development projects in rural areas led to the integrated development plans. The Sierra del Rosario Plan was one of those projects. Among the objectives of this project was the restoration of the environment, the advancement of the community and the enhancement of the livelihood of the villagers.

Besides the extensive construction of roads, another key outcome of this initiative included a major reforestation programme which included the planting of six million trees of precious timber.

As a result of the success of this project in 1985, UNESCO declared 25,000 hectares of Sierra del Rosario as Biosphere Reserve, the first one in Cuba.

The delegation visited some of the noteworthy sites within the community included:

- The Moka Hotel, that was purposefully designed to complement its surroundings. This is clearly demonstrated by the huge tree that spectacularly towers from the middle of the hotel's sky view lobby;
- Polo Montañéz' House, the last place of residence of the famous Cuban artist
  who initially practiced farming within the community. His family was among the
  first to settle down in the community;
- Paper recycling workshop and art studio of a resident who recycles waste paper that he uses for designing artistic posters, greeting cards, journals and other types of art and craft. The delegation commended the shop-owner for pursuing this type of 'green' or sustainable entrepreneurship.

#### Day 6: FRIDAY- SEPTEMBER 6th, 2024

## Federation of Cuban Women- the rights and advancement of women are fundamental to the people of Cuba

Obtaining greater insights into Cuba's philosophy and policies as it relates to the rights and advancement of women, was one of the key objectives of the official visit. In this regard, the delegation commenced day 6 with a visit to the headquarters of the Federation of Cuban Women. In 1960, Fidel Castro and Vilma Espin—a chemical engineer, feminist, and leader of the revolutionary movement in the eastern provinces—founded *The Federation of Cuban Women* to advance women's rights, gender equalization, and reproductive health rights<sup>11</sup>. The delegation met with Ms. Teresa Amarelle Boué, Secretary General of the Federation and other representatives.

Some of the notable points raised by representatives of the federation were as follows:

- the federation is not a state entity but was commissioned and established by decree of the government;
- Woman rights are protected in the Constitution of Cuba;
- In terms of maternity benefits, women are given 15 weeks of maternity leave and fathers are also entitled to paternity leave;
- 55% of the representative of the National Assembly of Cuba are women.

Speaker Annisette-George referred to the ongoing work of the recently formed Woman Parliamentarians of Trinidad and Tobago and indicated that the group would be willing to collaborate with the Cuban Woman's Foundation. In this regard, Speaker Annisette-George extended an invitation to the Foundation's Director to visit Trinidad and Tobago and participate in a Parliamentary gathering to be held in December 2024, which will focus on the issue of Gender Equality.

#### Meeting with Vice-Minister of Foreign Affairs

The delegation held a brief meeting with Hon. Josefina Vidal Ferreiro, Vice-Minister of Foreign Affairs. The Vice-Minister extended apologies on behalf of the substantive Minister (Hon. Bruno Eduardo Rodríguez Parrilla) who was unable to attend the meeting due to prior engagements.

During the meeting, Madam Speaker commended the government of Cuba for its efforts to restore and upkeep their historical and heritage buildings and infrastructure. Reference was also made to the continuous support rendered to Cuba by CARICOM in denouncing the economic sanctions that have been imposed on the country by the United States of America. The Vice-Minister described these sanctions against Cuba as the most severe and unmatched in the world. She reiterated that there was great anticipation on the part of her government for the Cuba-CARICOM Foreign Ministers conference to be held in Guyana in October, 2024.

#### Visit to the Ministry of Public Health

The final day of the official visit continued with a meeting with the Hon. José Angel Portal Miranda, Minister of Health. The meeting was held at the headquarters of the Ministry of Public Health.

The following were the main takeaways from the discussions:

- Cuba has approximately 11,000 doctors and offers comprehensive access to public health care for its citizens;
- Significant efforts are being made to enhance the capacity of Cuba's molecular biology laboratories;

- The country has a disease surveillance system that constantly monitors the progress of diseases and guides the administration of appropriate Disease Control mechanisms;
- There are 16 vaccines in circulation throughout the population of Cuba, eleven of these vaccines were produced in Cuba. The Cuban population presents very little to no resistance towards the use of vaccines;
- Program focuses on the dispensation of treatment to persons with noncommunicable diseases including cancer, hypertension, diabetes and kidney failure. Particular attention is given to diabetics that require amputations. Diabetic ulcer medication was created in Cuba to combat the level of diabetic amputations in the country;
- it was noted that Cuba rarely recorded any deaths due to dengue and other mosquito borne diseases;
- there are 88 Cuban healthcare professionals in Trinidad;
- In the year 2018, Cuba and Trinidad and Tobago signed an inter-ministerial agreement on the provision of healthcare. However, the renewal of this agreement is still pending.

#### Visit to the National Institute of Sport, Physical Education and Recreation

'To build a healthy nation every citizen must engage in sports at some level'

The National Institute of Sport, Physical Education and Recreation (INDER) was created in 1961. It is the body that governs all sport and recreation in Cuba and is analogous to a Ministry of Sport. The institute oversees the training of high level, competitive, world-class athletes<sup>12</sup>.

The delegation benefited from a presentation entitled "Characterisation of sports Education System".

Following the presentation, Madam Speaker commended the Institute for its work in developing world class sportsmen and Olympic champions and reflected on our country's efforts in the sporting disciplines including Netball, Cycling and Track & Field.

The Director of the institute extended an Invitation to the Minister of Sport and Community Development of Trinidad and Tobago, through Madam Speaker, to attend Cuba's commercial sports fair in February 2025. The director also offered to share the

#### Day 7: SATURDAY- SEPTEMBER 7th, 2024

#### Closing meeting with the Honourable President of the National Assembly

Before the departure of the delegation, a debriefing was held with Hon. Esteban Lazo Hernández, President of the National Assembly. The meeting allowed the delegation to reflect and share our experiences, observations and learnings. Speaker Annisette-George expressed her immense appreciation for the tremendous hospitality afforded to the delegation. Both parties agreed that this official visit marked a pivotal milestone in the strengthening of Parliamentary relations between Cuba and Trinidad and Tobago.

Madam Speaker used the opportunity to reiterate the position adopted by Trinidad and Tobago at the annual General Assembly of the United Nations which states that "The Government of the Republic of Trinidad and Tobago does not apply unilateral economic measures as a means of political and economic coercion against other countries." The Speaker also referenced the unjust inclusion of Cuba on the list of States that sponsors terrorism and underscored that Cuba is deemed compliant or largely compliant with 38 of 40 recommendations of the 2015 inter-governmental task force on terrorism financing, proliferation financing and money laundering.





#### **Departures**

Officials of the National Assembly were present at the diplomatic lounge of the "José Martí" International Airport to bid farewell to Madam Speaker and other members of the delegation.



The delegation then travelled to Panama and boarded a connecting flight to Port of Spain, Trinidad. The delegation arrived in Trinidad on Sunday September 08 2024 at 1:40 a.m. via COPA Airlines flight CM314.

#### **Conclusion and outcomes**

The delegation was tremendously honoured to have received such a gracious and hospitable reception from our Cuban colleagues. Given the structure and execution of the programme of activities, it was evident that a significant amount of planning and preparation was expended to ensure that Madam Speaker and the delegation had a productive, engaging and memorable experience.

Based on the seven days of extensive and fruitful interactions with the various governmental officials, it was reasonable to conclude that the main objectives of the visits were fulfilled. In many instances the discussions held established a starting point for the pursuit of future action on certain areas of mutual interest.

There were many notable takeaways from the visit, however, what mostly resonated was the resolute and abounding resilience of the people of Cuba and their leadership, notwithstanding the existence of significant hardship created by severe trade and economic sanctions. This along with a palpable spirit of patriotism and determination left an enormous impression on the delegation.

Additionally, the delegation acknowledges that although the purpose of the visit was to strengthen relations between the legislative branches of both countries, several potential opportunities for Executive or Ministerial action were highlighted at the various meetings held. The matters for the consideration and potential input of the Executive are listed in **Appendix 4.**
