Response to the Thirty-Second Report of the Public Accounts Committee on the F on the implementation of the recommendations in the Sixteenth Report of the Public Committee on the Examination of the Audited Financial Statements of the Trinidac Tobago Electricity Commission for the financial years 2012 to 2015

Recommendations:

- i. TTEC should report to Parliament on the current potential for the expansion of renewable energy production as a percentage of its overall electricity production by August 30, 2020;
- ii. The Ministry of Energy and Energy Industries should describe the composition and functioning of the Inter-Agency Committee that evaluates Expressions of Interest for the Beetham Waste to Energy project by August 30, 2020.

MEEI Response:

Cabinet agreed to the appointment of the Inter-Agency Evaluation Committee and it comprises a representative from each of the following Agencies:

- The Ministry of Energy and Energy Industries
- The Ministry of Planning and Development
- The Ministry of Public Utilities
- The Ministry of Finance
- The Office of the Commissioner of State Lands
- The Trinidad and Tobago Electricity Commission
- The Environmental Management Authority
- The Trinidad and Tobago Solid Waste Management Company Limited
- An International Consult(s) procured through the European Union's (EU) Technical Assistance Facility (TAF)
- iii. The Ministry of Energy and Energy Industries should provide Parliament with the precise timeline for the completion of the solar / wind energy project and the cost of the project by August 30, 2020;

MEEI Response:

The Project comprises of the development of two (2) Solar PV Power Plants situated Brechin Castle and at Trincity, with a capacity at 92.2 MW and 20MW respectively, on

a Build, Own and Operate (BOO) Basis. The total capital expenditure for being one hundred and twenty-three million dollars US dollars (US\$123 Million).

iv. The Ministry of Energy and Energy Industries should submit a progress report to Parliament regarding its evaluation of bids for the WtE project and the expected relaunch date for this project by August 30, 2020;

MEEI Response:

In July 2016, the GoRTT approved the establishment of a Waste-to-Energy (WtE) Facility at the Beetham Landfill Estate in Port of Spain. The WtE Facility is intended to contribute to the modernisation of an Integrated Municipal Solid Waste System and the achievement of Sustainable Energy Targets in T&T.

The MEEI sought Expressions Of Interests from qualified Developers with in-depth experience in WtE on a Build Own and Operate (BOO) basis. Following the Evaluation

process, the MEEI invited twenty-eight (28) qualified Developers to participate at the RFP Stage on January 17, 2019. The deadline for the submission of Proposals was August 30, 2019.

The MEEI engaged the EU for the provision of Economic and Technical Consultants. vever, the timeframe for procurement (two to three months) did not align with the ulated deadline of August 30, 2019. Therefore, the MEEI was forced to withdraw n the TAF. The MEEI alternatively opted to seek a Consultancy via an Advertisement testing Proposals, and an in-house Inter-Agency evaluation.

as noted, that the expertise of this Consultancy did not exist in the country hence, the EI decided to re-engage the EU Delegation for support. The EU Delegation is ently investigating the possibility of financing this Consultancy under another Grant ility. Plans are in place to proceed with the evaluation of the bids.
