- 2. The Committee also participated in a **Peer to Peer Exchange**, which was hosted and moderated by the International Republican Institute (IRI) on June 27, 2022. Presentations on campaign financing were given by:
  - Hon. Jatzel Roman, Vice Minister for Consular and Immigration Affairs of the Dominican Republic;
  - Hon. Mathias Mpuuga, MP, Leader of Opposition, Parliament of Uganda;
  - Hon. Abdullahi Sa'ad Abdulkadir, MP, Deputy Chair of the Public Accounts Committee (PAC), House of Representatives of Nigeria; and
  - Mr. Krzysztof Lisek, IRI Resident Program Director, Former Member of the European Parliament and Deputy Chairman of the Security and Defence Subcommittee, Former MP in the Parliament of Poland.
- 3. The Peer to Peer Exchange provided members of your Committee with the opportunity to learn from former and current parliamentarians around the world on the best practices, challenges and lessons learned on issues relevant to the draft legislation.
- 4. Attendance records and minutes of the meetings are attached at Appendix I.

#### **INTERIM REPORT**

5. The Committee's Interim Report was laid in the House of Representatives on Friday April 29, 2022 and presented in the Senate on Tuesday May 10, 2022. Your Committee requested and was granted a five (5) month extension to Friday September 2, 2022 in order to complete its work.

#### **WORK TO DATE**

- 6. Technocrats from the Law Reform Commission were invited to assist the Committee with its consideration of the Bill.
- 7. The technocrats of the Law Reform Commission commenced by delivering a comprehensive presentation on the background of the proposed legislation and provided your Committee with research materials for a greater appreciation of the policy objectives and the key

features of the Bill, as well as comparative legislation. Representing the Law Reform Commission were:

- Mrs. Paula Cross-Horton, Senior Legal Research Officer (Policy); and
- Ms. Tamara Dookran, Senior Parliamentary Counsel (Drafting).
- 8. The following technocrats from the Office of the Chief Parliamentary Counsel were also assigned to assist Committee with its deliberations:
  - Mrs. Lorraine John, Assistant Chief Parliamentary Counsel; and
  - Mr. Parvin Sookhai, Parliamentary Counsel III (Ag.).
- 9. During preliminary discussions your Committee agreed to issue an additional call for written submissions from the public to ensure public engagement in the Committee's process. The call for public comments was published on the Parliament's social media platforms and in the daily newspapers.
- 10. In addition, your Committee agreed to request written submissions from political parties and civil society, as well as other stakeholders that may be affected by the Bill. The list of stakeholders is attached at **Appendix II**.
- 11. During this Session, submissions were received from eleven (11) stakeholders and to date, a total of twenty-six (26) submissions have been received from the following entities:

- 12. Your Committee has also decided to consult with an expert during its deliberations on the draft legislation and has solicited and received recommendations from several regional and international entities. - 13. To date, four (4) experts were recommended to and considered by the Committee, namely:
  - Mr. Charles Chauvel, Global Lead on Inclusive Institutions and Processes, UNDP, and former member of the House of Representatives in the Parliament of New Zealand.
  - 2. Mr. Salvador Romero, former president of the Supreme Electoral Tribunal of Bolivia on two occasions, former director of the Centre for Electoral Advice and Promotion (CAPEL), and the former executive secretary of the Electoral Organisations of the Americas.
  - 3. Mr. Grant Masterson, Head of Programme, Governance, Electoral Institute for Sustainable Democracy in Africa (EISA); and
  - 4. Mrs. Maxine Henry- Wilson; former Jamaican parliamentarian, Government Minister and Member of the Electoral Advisory Commission

#### **REPORT**

- 14. The Committee wishes to report that additional time is required by the Committee to review all submissions received, meet with stakeholders as required and complete the clause by clause analysis of the Bill for a proposed list of amendments to be compiled.
- 15. The Committee is also desirous of additional time to select an expert who will aid the Committee in its review of the Bill.
- 16. Consequently, in accordance with Standing Orders 114(1) and 104(1) of the House of Representatives and the Senate respectively, your Committee wishes to report that due to the imminent prorogation of the Second Session of the Twelfth Parliament, it is unable to complete its work. However, your Committee has made considerable progress in advancing its work.

#### RECOMMENDATION

- 17. Your Committee therefore recommends the resumption of proceedings on the Representation of the People (Amendment) (No.2) Bill, 2020, in the Third Session, Twelfth Parliament.
- 18. Your Committee also asks that the House take note of the work achieved and the progress made by the Committee thus far and that a Committee be appointed in the Third Session to continue work on the Bill and adopt as part of its records, all work completed to date.

  - The following Attorneys-at-Law assigned to assist the Committee by the Office of the Chief Parliamentary Counsel (CPC) were invited to join the Committee's meeting:
    - Ms. Lorraine John, Assistant Chief Parliamentary Counsel, Legislative Drafting Department (Drafting); and
    - Mr. Parvin Sookhai, Parliamentary Counsel, Legislative Drafting Department (Drafting).
  - 2) Mrs. Paula Cross Horton, Senior Legal Research Officer, Law Reform Commission was also invited to join the Committee's meeting.

#### STAKEHOLDER SUBMISSIONS

- 4.1 The Chairman advised that the following organisations requested extensions of the deadline for submissions:

  - via electronic correspondence dated Thursday April 28, 2022, Mr. John E. Lewis, Regional Peace and Development Advisor for the United Nations in the Caribbean, advised that the Department of Political and Peacebuilding Affairs (DPPA), UNDP, would defer to UNDP Trinidad and Tobago on the recommendation of an expert;
  - via electronic correspondence dated Thursday May 5, 2022, Ms. Jessica Birks, Political Counsellor, High Commission of Canada, responded to the Committee's request for expert assistance from Mr. Jean Pierre Kingsley, who served as the president and CEO of the International Foundation for Electoral Systems and was the Chief Electoral Officer of Elections Canada. She advised that Mr. Kingsley has requested additional information and would thereafter decide whether to submit his name for consideration;
  - via email dated Thursday April 28, 2022, the International Republican Institute (IRI) made the following proposals for two types of pro-bono, short-term technical expertise:

#### Proposal 1

O IRI has identified Mr. Salvador Romero, former president of the Supreme Electoral Tribunal of Bolivia on two occasions, former director of the Center for Electoral Advice and Promotion (CAPEL), and the former executive secretary of the Electoral Organizations of the Americas. Mr. Romero would be able to provide an initial assessment of the JSC's needs and existing draft legislation over two to three virtual working sessions. Mr. Romero has extensive experience collaborating with legislators and political actors across Latin America and the Caribbean and has recently completed a similar assessment for the IRI in Ecuador.

#### Proposal 2

- IRI proposes to organise a series of virtual peer-to-peer exchanges with current and former government officials such as:
  - Hon. Santia Bradshaw, current member of Parliament (MP) and Deputy Prime Minister of Barbados;
  - Mr. Jatzel Román, Vice Minister of Foreign Affairs of the Dominican Republic;
  - Hon. Aisha Dukku, current MP in Nigeria;
  - Krzysztof Lisek, former MP in the Polish and European Parliament; and
  - Rt. Hon. Mathias Mpuuga, current MP in Uganda.

IRI has found that these peer-to-peer exchanges can provide practical insights, best practices and lessons learned on complex topics such as political party and campaign financing laws. IRI further advised that, upon request, a more extensive list of potential experts from its global network or a more extensive list of potential speakers from its global network could be identified.

- 4) via email dated Monday May 9, 2022, the Electoral Institute for Sustainable Democracy in Africa (EISA) submitted the CV of Mr. Grant Masterson for the Committee's consideration. Mr. Masterson is the Head of Programme, Governance, EISA, and has considerable expertise in strengthening democratic processes, observing elections, and supporting political parties; and
- 5) all CVs received from experts to date have been uploaded to the Rotunda Application.

#### **WAY FORWARD**

- 6.1 Following a brief discussion, the Committee agreed that:
  - 1) the Secretariat will communicate to stakeholders the new deadline for submissions which is Monday May 23, 2022;
  - 2) the Secretariat will contact Mr. Jean Pierre Kingsley former Chief Electoral Officer of Elections Canada to clarify his request for further information;
  - 3) Members will give feedback on their preferred experts by Friday May 13, 2022;
  - 4) the Secretariat will liaise with the IRI on arranging the proposed Peer to Peer Exchange on **Monday June 6, 2022**, if convenient;
  - 5) the Secretariat will prepare a summary on the system of electoral reform for each panelist in the Peer to Peer Exchange; and
  - 6) the Attorneys of the Law Reform Commission and the Chief Parliamentary Counsel who have been assigned to assist the Committee will be invited to attend the Peer to Peer Exchange.

- (d) 2003-2012- Member of Parliamentary subcommittee considering the Bills on Electoral Reform.
- (iii) Mr. Grant Masterson, Head of Programmes: Governance, for the Electoral Institute for Sustainable Democracy in Africa (EISA). Mr. Masterson possesses over 20 years of experience in the democracy and governance field, specialising in African elections, democratic processes and institutions in the non-profit space. He served as an Election Observer to over 30 elections.
- (iv) Mr. Charles Chauvel, Global Lead on Inclusive Institutions and Processes, United Nations Development Programme (UNDP); former Advisor on Parliamentary Development (UNDP); and former Member of Parliament in New Zealand. Mr. Chauvel provides policy advice and programme support to UNDP regional hubs and country offices on civic engagement, constitution-making, elections, parliaments and women's political participation.
