This Report outlines the Business conducted by the Parliament of Trinidad and Tobago during this Second Session of the Twelfth Parliament.





DEFINITE MATTERS OF URGENT PUBLIC IMPORTANCE

Guided by Westminster Parliamentary Practice, Standing Order 17 of the House of Representatives speaks to Definite Matters of Urgent Public Importance. For a matter to be debated, all three substantive criteria must be met.

1. Definite:

- the matter must not only be specific, but its facts must be settled; and
- the matter, event or issue must be certain, not hypothetical; or even worse, presumptive.

2. Urgent:

- the nature of the crisis or emergency must demand the prompt attention of the House;
- the matter must be exceedingly urgent, that is, it arose suddenly, is of a pressing nature, and has potentially serious consequences; and
- a matter that has been ongoing for some time will not qualify, such as crime, foreign exchange shortages or unemployment. Although these matters are important, they do not qualify under Standing Order 17;
- the urgency should be such that the matter allows no delay and for which a motion or a resolution with proper notice will be too late.

 Consequently, a matter that could have been raised at a previous sitting and was not so raised, cannot satisfy the rule; and
- a matter which can be discussed in the ordinary course of business, should not cause the House to set aside its prearranged business.

3. Public Importance:

• the matter affects the entire country and its urgency and gravity justifies it.

There were nine (9) matters filed by Members of the HOR as definite matters of urgent public importance, however they did not qualify to be raised.





DEFINITE MATTERS OF URGENT PUBLIC IMPORTANCE

Guided by Westminster Parliamentary Practice, Standing Order 16 of the Senate speaks to Definite Matters of Urgent Public Importance. For a matter to be debated, all three substantive criteria must be met.

1. Definite:

- the matter must not only be specific, but its facts must be settled; and
- the matter, event or issue must be certain, not hypothetical; or even worse presumptive.

2. Urgent:

- the nature of the crisis or emergency must demand the prompt attention of the House;
- the matter must be exceedingly urgent, that is, it arose suddenly, is of a pressing nature, and has potentially serious consequences; and
- a matter that has been ongoing for some time will not qualify, such as crime, foreign exchange shortages or unemployment. Although these matters are important, they do not qualify under Standing Order 16;
- the urgency should be such that the matter allows no delay and for which a motion or a resolution with proper notice will be too late. Consequently, a matter that could have been raised at a previous sitting and was not so raised, cannot satisfy the rule; and
- a matter which can be discussed in the ordinary course of business, should not cause the House to set aside its prearranged business.

3. Public Importance:

• the matter affects the entire country and its urgency and gravity justifies it.

Section 66A (1) of the Constitution states inter alia:

"...Joint Select Committees to inquire into and report to both Houses of Parliament in respect of –

- (A) Government Ministries
- (B) Municipal Corporations;
- (C) Statutory Authorities;
- (D) Enterprises owned or controlled by or on behalf of the State or which received funding from the State of more than two third of its total income in any one year; and
- (E) Service Commissions, in relation to their administration, the manner of the exercise of their powers, their methods of functioning and any criteria adopted by them in the exercise of their powers and functions;

STANDING ORDERS 88 (2) and 99 (1) of the Senate and House of Representatives respectively give effect to the operations of these Committees.

These Committees are established for the life of a Parliament.

PUBLIC ACCOUNTS COMMITTEE (PAC)

Section 119(1) of the Constitution of the Republic of Trinidad and Tobago provides for the establishment of the PAC. The PAC examines reports of the Auditor General on the various Accounts of Government Ministries and Agencies. The PAC is assisted by the Auditor General and has powers to send for persons, papers and records.


COMPARATIVE GRAPHS

APPENDIX IV

POINTS OF INTEREST

❖ <u>Meeting of the Electoral College/Constitutional Motion</u>—On Thursday October 21, 2021, the Electoral College comprising the Members of both the House of Representatives and the Senate, met to consider whether section 36(1) of the Constitution of the Republic of Trinidad and Tobago should be triggered. This was the first time in the nation's history that the College met to consider the removal of a President, the incumbent Her Excellency, Paula-Mae Weekes, ORTT.

The matter of the removal of the President of Trinidad and Tobago originates from public interest surrounding the mismanagement of the appointment and then suspension of Mr. Gary Griffith as Acting Commissioner of Police by the former Police Service Commission. The four (4) former Members of that Police Service Commission, including its Chairman Ms. Bliss Seepersad, resigned and subsequently the merit list for the selection of an Acting Commissioner of Police, which was submitted to the President of the Republic, was rescinded.

Following these events, the Leader of the Opposition and MP for Siparia, Mrs. Kamla Persad-Bissessar, SC filed a Motion in Parliament. The Motion was signed by all nineteen (19) Opposition Members, in accordance with the provisions of section 36(1) of the Republican Constitution. The Opposition outlined that the rescission of the merit list was an erroneous act and sought answers from the President's Office and its part in tainting the process due to political interference.

In observance of section 36(1), where the motion is approved by not less than two-thirds of the total membership of the Electoral College, a tribunal will be appointed consisting the Chief Justice and four (4) other Judges appointed by him, who will lead an investigation into the allegations made against the President. Following which a report will be sent to the College and another resolution supported by not less than two-thirds of the total membership of the Electoral College is required in order to have a President removed.

The Electoral College convened to vote on the motion that the removal of the President be investigated by a tribunal, which as stated required a two-thirds majority vote to be approved. With 24 votes for, 47 votes against and no abstentions, the motion was defeated.

❖ Standing Order 45 (1) — On March 23, 2022, the Speaking Time for debates was adjusted to somewhat pre COVID-19 pandemic lengths, where the mover and first responder are allowed a maximum of 45 minutes; all other speakers a maximum of 30 minutes; and the mover in reply a maximum of 30 minutes. However, all with no extension.

Non-Participation by Opposition Members on SSC (Senate) on a Code of Ethical Conduct and Behaviour for Senators - Pursuant to a resolution of the Senate on Tuesday June 28, 2022, a Special Select Committee was established to consider and report by July 08, 2022 on a Code of Ethical Conduct and Behaviour for Senators. The resolution stated as follows:

"BE IT RESOLVED that this Senate censure the unparliamentary conduct of said Opposition Senators who by threat or molestation have attempted to obstruct, impede, influence or interfere with said Independent Senators in the performance of their duties;

AND BE IT FURTHER RESOLVED that a Select Committee be established to consider and report on a code of ethical conduct and behavior for Senators."

At its First Meeting held on Wednesday June 29, 2022, the Chairman noted that no member of the Opposition Bench was appointed to serve on the Committee. The Opposition Bench stated that it would not be participating in the Committee.
