INTRODUCTION

The Second Session of the 11th Parliament began on September 23rd 2016 by Proclamation of His Excellency (Legal Notice 134 of 2016) and prorogued on September 21st 2017 by Proclamation of His Excellency (Legal Notice 105 of 2017).





OVERSIGHT DEPARTMENTAL JOINT SELECT COMMITTEES OF PARLIAMENT APPOINTED IN ACCORDANCE WITH SECTION 66A OF THE CONSTITUTION

MANDATE

Section 66A (1) of the Constitution states inter alia:

"...Joint Select Committees to inquire into and report to both Houses of Parliament in respect of –

- (A) Government Ministries
- (B) Municipal Corporations;
- (C) Statutory Authorities;
- (D) Enterprises owned or controlled by or on behalf of the State or which received funding from the State of more than two third of its total income in any one year; and
- (E) Service Commissions, in relation to their administration, the manner of the exercise of their powers, their methods of functioning and any criteria adopted by them in the exercise of their powers and functions;

STANDING ORDERS 88 (2) and 99 (1) of the Senate and House of Representatives respectively give effect to the operations of these Committees.

These Committees are established for the life of a Parliament.

PUBLIC ACCOUNTS COMMITTEE (PAC)

Section 119(1) of the Constitution of the Republic of Trinidad and Tobago provides for the establishment of the PAC. The PAC examines reports of the Auditor General on the various Accounts of Government Ministries and Agencies. The PAC is assisted by the Auditor General and has powers to send for persons, papers and records.




This graph illustrates the number of questions filed and answered in both houses during the Second Session of the Eleventh Parliament.






POINTS OF INTEREST

- ❖ Prime Minister before a JSC − Dr. Keith Rowley, MP became the first sitting Prime Minister in the Country's history to appear before a Joint Select Committee of Parliament. On Monday September 18, 2017 the Prime Minister appeared before the Committee on Land and Physical Infrastructure which was investigating the Inter Island Ferry Service.
- Extraordinary Sitting The Standing Orders provides that "If at any time when the House stands adjourned pursuant to its own order the Speaker is satisfied that there is urgent necessity for the House to meet upon a day earlier..." One such sitting of the House of Representatives was held on January 20, 2017 and January 21, 2017 in the Senate.
- Procedural Bulletin Procedural Bulletin No. 2 was issued in the Senate on September 23, 2016 and September 26, 2016 in the House of Representatives. The bulletin addressed the Committee on Government Assurances and the method or manner by which those assurances will be monitored in the Chamber.
- Casting Vote the Speaker used her Casting Vote, in favour of the Government, three (3) times in the House of Representatives on Friday September 08, 2017.
